Panelists will introduce the PLRA and contrast its purpose with how it's been implemented over the last 25 years. Attorneys interested in working with prisoners will learn what hurdles indigent incarcerated litigants must overcome before a court will appoint counsel. Attendees will leave with strategies to communicate effectively with their incarcerated clients, who may not have privacy or Internet access.

Integral to this program is confronting the implicit and explicit biases present in the prison litigation system, especially in how the PLRA is enforced. Attorneys attending this CLE will gain critical education that they can apply to their practices. The panelists will discuss the biases their clients face, and share stories of bias and discrimination faced by pro se litigants. Tips on how to work with pro bono clients in PLRA litigation will include ways to recognize and confront the biases that the client faces in the prison litigation system. Whether they practice pro bono in the space or not, attending attorneys will receive insight and education on these systemic biases and ideas from the panelists on how we as a society and as attorneys can combat them.
