Panels will explore progress, setbacks, and opportunities in these areas, including how California state courts can increase diversity and representation through novel initiatives, how leaders in the legal industry can move past performative diversity and towards meaningful cultural change, how inside and outside counsel can work together to promote, advocate and ensure diverse attorneys receive meaningful opportunities, and the importance of these efforts to our community as a whole.

SESSION I | 9:15 - 10:30 a.m.

A Jury of Your Peers

A Look at Past Issues and Future Solutions for Increasing Juror Diversity MCLE: 1 Hour in Elimination of Bias

Join Berkeley Law Professor, Elisabeth Semel, Brendon Woods, the first African-American Chief Public Defender of Alameda County, and Tamani Taylor, San Francisco Deputy Public Defender, for a discussion of the history of racial discrimination in jury selection in California. In 2020, Semel and students in Berkeley Law's Death Penalty Clinic published, "Whitewashing the Jury Box: How California Perpetuates the Discriminatory Exclusion of Black and Latinx Jurors," which provided evidentiary support for the California Legislature's passage of AB 3070. Woods, Semel, and clinic students played instrumental roles in the legislative process. This statute dramatically reforms jury selection in criminal trials, and in 2026 it will also apply to civil jury selection.

SESSION II | 10:40 - 11:55 a.m.

Diversity of California's Legal Profession Report

MCLE: 1 Hour

A presentation on the State Bar of California's "diversity report card" and strategies for attorneys and employers to increase diversity, equity, and inclusion in their workplaces and the profession. Participants will learn about the current demographic composition of California attorneys, including analyses that explore where attorneys work, their leadership experiences, and satisfaction with workplace experiences crucial to advancement and retention. While the State Bar's report shows that the profession has become increasingly diverse in recent decades, an analysis of women of color in the profession highlights that there are great opportunities to improve diversity, equity, and inclusion in the profession. Calls to action, or strategies, for both legal employers and attorneys, will be shared to help employers and attorneys advance an inclusive workplace in support of a profession that reflects the diversity of California.
